Coming in early 2024: the first research report in our series on philanthropic advisors

Philanthropic advisors play a crucial role in helping families and organizations create impact and social change, but very little is known about them. Who are they? How do they learn their trade? Who do they serve? How do they carry out their work? And exactly what impact do they have on the philanthropic sector?

Last fall, as a first step toward mapping our fragmented field, we launched the first survey of its kind to understand the experiences of philanthropic advisors. Respondents represented a variety of roles, including those in private practice, community foundations, other nonprofit organizations, banks, and investment management firms.

We learned that these individuals create real impact! Our respondents each facilitated an average of \$50 million in philanthropic giving last year. DAFs were among the most commonly used charitable tool.

We also learned that the field is becoming more diverse. In fact, over half of respondents who were new to their role as an advisor—defined as having fewer than 10 years of experience—were BIPOC.

Our sincere thanks to all who took the time to complete the survey. Look for the full report to be released in early 2024, along with a series of interactive webinars in which we will discuss implications and recommendations.
